



## **AMENDMENT TO THE UNIVERSAL REGISTRATION DOCUMENT OF CAIXABANK, S.A. REGISTERED WITH THE OFFICIAL REGISTRIES OF THE COMISION NACIONAL DEL MERCADO DE VALORES ON 18 APRIL 2023**

This amendment (hereinafter, the "**Amendment**") to the Universal Registration Document of CaixaBank, S.A. (hereinafter, the "**Issuer**"), which has been drafted in accordance with Annex II of Regulation (EU) 2017/1129 of the European Parliament and of the Council and Annex 2 of Commission Delegated Regulation (EU) 2019/980 and registered with the Official Register of the Comisión Nacional del Mercado de Valores (hereinafter, the "**CNMV**") on 18 April 2023 under official entry 11269, has been prepared in accordance with article 9 of Regulation (EU) 2017/1129 of the European Parliament and of the Council.

This Amendment must be read jointly with the Universal Registration Document and, as the case may be, with any other amendment of supplement to such Universal Registration Document that the Issuer may publish in the future.

This Amendment has been approved by the CNMV as competent authority by virtue of the Regulation (EU) 2017/1129. The CNMV only approved this Amendment as meeting the requirements imposed by Regulation (EU) 2017/1129.
