1. INTRODUCTION

The Activity Report is the document that includes the preventive steps carried out at CaixaBank during the year 2022.

The preventive activities are defined in the annual preventive planning, which is performed in accordance with the following:

- the principles established in the Prevention Plan, considered the guiding document on the prevention of occupational risks
- the requirements established in the management system based on the OHSAS 18001 certification standards, which is currently in the migration phase to the ISO 4500 standards

The Joint Prevention Service of "la Caixa" Group (hereinafter, "SPMGLC") manages prevention at CaixaBank. Its main mission is to advise with the aim of guaranteeing the adequate safety, health and wellbeing of employees and mitigating its accident rate.

The SPMGLC coordinates with CaixaBank from the Labour Relations department and is assisted by the Single Committee on Occupational Health and Safety (hereinafter, "CUSSL").

The technical specialties (Safety at Work, Industrial Hygiene, Ergonomics and Applied Psychosociology) are assumed by the SPMGLC. In the specialty of Occupational Medicine (Health Surveillance), it has opted for collaborating with the External Prevention Service "QuirónPrevención".

The preventive activities detailed in this report are divided into the following chapters:

PREVENTIVE ACTIVITIES			
Management	It details the management of the prevention, stemming from the annual planning, carried out during the period under study.		
Safety at Work	It describes the actions carried out in the technical specialty of Safety at Work. The activities are performed through the risk assessment, planning and monitoring of preventive measures. It includes emergency-related activity.		
Industrial Hygiene	It comprises preventive activities related to the specialty of Industrial Hygiene, focusing on environmental and specific assessments.		
Ergonomics	It consists of the activities carried out in the specialty of Ergonomics of the workplace and the equipment provided to the staff.		
Applied Psychology	It compiles information on the actions carried out in the field of Psychosociology, according to the preventive programme stemming from the evaluation of psychosocial factors.		
Occupational Medicine	It documents the steps taken by the Health Surveillance Service (Quirón Prevención).

2. OCCUPATIONAL RISK PREVENTION MANAGEMENT



Since 2005, CaixaBank has established its preventive management system in accordance with international standard OSHAS 18001, which is currently in the migration stage to ISO 45001 standards.

2.3 Coordination of business activities

2.4 Occupational risk prevention audit


Since 2005, CaixaBank's occupational health and safety management system has been based on the OHSAS 18001 standard. The certified auditing entity Audelco, S.A. supervises and renews the entity's certification in the times established by regulations and based on the chosen management system, valid until 30/09/2021. On that date, a process of transitioning to the ISO 45001 standards was initiated.

2.5 CUSSL (Single Committee on Occupational Health and Safety) meetings and participation

Regular meetings are held quarterly within the scope of the CUSSL, and extraordinary meetings are held at the request of either party to discuss specific issues that may be of interest.

2. 6 Accident rate

CaixaBank's Annual Incident Rate* stands at 2.20. The index is higher than the sectoral index (1.60 according to the latest data provided by the Ministry of Labour for 2021). This increase is due to the economic recovery, since it compares us with the year 2021, in the context of a COVID-19 health crisis, during which the entire economy slowed down. (*) Annual Incident Rate (excluding in itinere)



In 2022 a total of 350 accidents have been recorded, with the following distribution:

56% of the accidents recorded in 2022 have been classified as "accidents without sick leave", whereas 44% involved sick leave. We can observe a slight decrease in the total number of accidents compared to 2021.

The mutual accident society classifies accidents according to severity: minor, serious, very serious or fatal accidents. According to this classification, the following results have been obtained for 2022:

3. SAFETY AT WORK

Risk assessment is a dynamic process geared towards estimating the magnitude of the risks that could not be avoided and obtaining the necessary information to adopt the corresponding preventive measures.

At CaixaBank, the occupational risk assessments are carried out in accordance with the criteria and frequency established in its management system and based on the legally established requirements.



4. INDUSTRIAL HYGIENE

Environmental factors that may affect the health of the workforce are periodically reviewed. To this end, the environmental conditions are assessed and measurements of carbon dioxide (CO2) levels, temperature, relative humidity, lighting, air velocity and noise are carried out.

Furthermore, specific studies are carried out in particular cases where the conditions of the centre require it. Specifically, and as a consequence of the health emergency arising from COVID-19, the risk of exposure to the virus in the work environment has been assessed. In the analysis and assessment of the risk exposure, the "Action Procedure for Occupational Risk Prevention Services against Exposure to SARS-CoV-2" has been considered. The specific assessment of COVID-19 concludes that there is a low probability of exposure due to the work activity carried out in CaixaBank work centres.



The information relating to the pandemic's management is detailed in section 9 of this document.

5. ERGONOMICS

In accordance with the principles of ergonomics, workstations are adapted to the physical needs of individuals. The valuation and supply of the following equipment has been managed:

6. PSYCHOSOCIOLOGY

In 2022, continuing with the objective of promoting well-being at work by means of psychosocial prevention, a reassessment of psychosocial risk factors was carried out, considering the inclusion of all the company's employees.

In agreement with the workers' representatives, this assessment was carried out using F-Psico, a tool created by the INSST (National Institute of Health and Safety in the Workplace), after consulting the assessment process and its monitoring. The prevention delegates were present as observers in the second phase of the process, during the execution of the working groups that were created and that enjoyed the participation of the employees to understand the exposure of psychosocial risk situations, their nature and their causes, reflecting together on the lines of action and initiatives for the improvement of psychosocial factors.

After analysing the results obtained from the 13,591 questionnaires and the qualitative analysis of the employees, which were compiled in the working groups, aspects that could be improved have been observed. It is considered relevant to integrate them into action plans designed by the different directorates involved, each of them in their field of responsibility and within a corporate psychosocial preventive strategy.

7. OCCUPATIONAL MEDICINE

Occupational medicine is performed through the External Prevention Service, which by means of health surveillance, assesses the possible effects of work on the workforce's health.



QuirónPrevención prepares the report on the activities carried out in 2022, which includes a list of the actions carried out in this specialty.

7.1 Particularly sensitive employees

CaixaBank considers PSE those people who have limitations or pathologies that affect their work activity. Interested parties have at their disposal the request for a PSE evaluation in the internal instruction established in the management system. Subsequently, the Health Surveillance Service carries out the corresponding medical assessment.

During 2022, the Health Surveillance Service has analysed, on an individual basis, the requests of particularly sensitive employees (cases of individual susceptibility, pregnancy and lactation). The requests resolved in 2022 amount to 158.

7.2 Medical examinations

In accordance with article 22 of Occupational Risk Prevention Act 31/1995, all employees are offered annually the possibility of carrying out a medical examination through the health surveillance service, with the aim of detecting early any sign of suffering or a predisposition to develop work-related diseases.

Health surveillance is carried out in line with the medical protocols associated with the inherent risks of the jobs, according to the occupational risk assessment. During the study period, 1571 health examinations were carried out.

9. PREVENTIVE MANAGEMENT OF COVID

The evolution of the health crisis has made it necessary to continuously adjust the adopted measures and the different management procedures in accordance with the epidemiological situation, health recommendations and applicable regulations. The Business Continuity Monitoring Committee has always defined the different policies for both prevention and health and safety.

In March, the Ministry of Health updated the surveillance and control strategy against COVID-19, based on a favourable evolution of the pandemic for the elapsed period of 2022.

Given the new epidemiological context, CaixaBank continued with the review and adaptation of all the preventive measures it had implemented and gradually began to deactivate them in several phases.

In June, CaixaBank decided to close the COVID-19 incident, following internal consensus between the parties involved in the different decision-making processes and the coordination of activities related to the pandemic. Subsequently, a new prevention and hygiene protocol against COVID-19 came into force, with permanent measures. This protocol is subject to any possible modifications or updates by the competent health authorities at any time.
